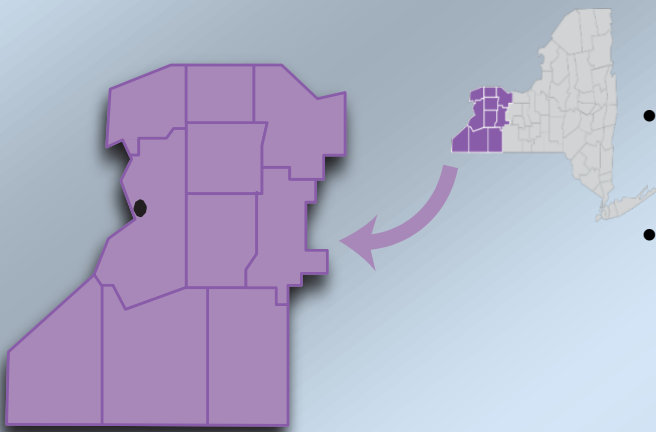


What is MMHCT?

The Mobile Mental Health Consultation Team (MMHCT) is an assessment and consultation service for children and adolescents up to age 18. The MMHCT accepts referrals from the following counties and probation departments and family courts:

- Allegany
- Cattaraugus
- Chautauqua
- Erie
- Genesee
- Monroe
- Niagara
- Orleans
- Wyoming

Referrals for problematic and illegal sexual behaviors, threat assessments and fire risk assessments are received from the SPOAs, Probation and Family Courts. Referrals are also received for general mental health evaluations.



Program Scope:

The primary function of the MMHCT is to provide diagnostic screenings, evaluations, and consultations to help determine clinical diagnosis, treatment recommendations and the need for further mental health interventions.

The MMHCT clinicians can travel to various mental health agencies and probation departments to complete evaluations. It is the primary goal of the MMHCT to facilitate, improve and augment mental health services of youth who are involved within the criminal justice system or mental health organizations.

Guidelines for Referral:

- Referrals are received from County Probation, SPOA, Family Courts, PACC and special requests from other agencies.
- A MMHCT referral requires parental consent prior to consultation and/or a family court order signed by a judge.
- Referral for evaluation is completed by the referring agency to identify the specific need for the assessment.

- Upon referral, the MMHCT will contact the referring agency and family to schedule consultation.
- Report is submitted to the referring agency or to the Family Court Judge.

Eligibility Criteria:

- Family Court request
- Youth's involvement in the juvenile justice system, detention or probation
- Need for treatment and disposition recommendations for high risk behaviors:
 - problematic or illegal sexual behaviors
 - acts of violence and/or threats
 - fire setting behaviors
- Youth is typically not in an acute hospital, RTF or diagnostic setting
- Parental/guardian consent or Family Court order is required
- May or may not be enrolled in mental health program

Services the MMHCT provides:

- Evaluation and Assessment
- Case Consultation
- Treatment Recommendations
- Risk Management/Safety Planning
- Assisting referral sources with linkages to mental health services if needed

- Provide presentations to community partners on threat assessments (violence/sexual risk)
